Fire Prevention Act 207 Section 29.19 (as amended effective July 1, 2014) outlines the requirements for schools operating any of grades kindergarten to 12. The specific sections for Fire Drills, Tornado Drills and Lock Downs are listed below. In addition, the following pertains to ALL DRILLS in Section 19 of the Act:

Sec. 19 (6) A school that operates any of grades kindergarten to 12 shall conduct at least one (1) of the drills required by this section during a LUNCH or RECESS period, or at another time when a significant number of the students are gathered but not in the classroom.

Fire Drills

Sec. 19 (3) five (5) fire drills is required for each school year for a school that operates any of grades kindergarten to 12.

Three (3) of the fire drills shall be held by December 1 of the school year, and (2) shall be held during the remaining part of the school year, with a reasonable spacing interval between each drill.
